ACKNOWLEDGMENT AND ACCEPTANCE OF RISKS AND LIABILITY RELEASE**

In consideration for being allowed to participate as part of the **Canis Lupus Challenge** (“The Event”)

I, the “Participant”, (“THE UNDERSIGNED” means only the PARTICIPANT when the PARTICIPANT is age 18 or older **OR** it means both the PARTICIPANT and the PARTICIPANT’s parent or legal guardian when the PARTICIPANT is under the age of 18.)
_____ understand, agree to and except the following:

WARNING: All forms of Alpine and other related mountain activities are hazardous – your safety is directly affected by your judgment. Ride/Ski only within your ability. Be alert to the many risks of the sport including, but not limited to changing weather, visibility and surface conditions, man-made and natural objects, snow vehicles, design, and condition of natural and man-made features.

Competitive Snowboarding/Skiing has numerous risks including, but not limited to falls associated with the use of natural and man-made snowshapes, severe terrain changes, equipment failure, hard or uneven landings and collisions with other competitors, spectators and natural and man-made objects.

In consideration of allowing the Participant to participate in the EVENT, THE UNDERSIGNED hereby agree to **ASSUME ALL RISKS** associated with the PARTICIPANT’s participation in the EVENT. Additionally, THE UNDERSIGNED agree to **HOLD HARMLESS, RELEASE, DEFEND, AND INDEMNIFY**, ASC Utah dba The Canyons, American Skiing Company, its affiliated organizations and companies, and each of their respective insurance carriers, agents, employees, representatives, assignees, officers, directors, and shareholders (each hereinafter a “RELEASED PARTY”) for **ANY AND ALL LIABILITY** and/or claims for injury or death to persons or damage to property arising from the PARTICIPANT’s participation in the EVENT, **including those claims based on any RELEASED PARTY’s alleged or actual NEGLIGENCE OR BREACH OF any express or implied WARRANTY.**

THE UNDERSIGNED further agree and understand that risks associated with the EVENT, in addition to those previously listed, include, but are not limited to: equipment malfunction; surface conditions; marked and unmarked obstacles; rugged mountainous terrain; slick or uneven riding and walking surfaces, surfaces covered with ice and snow; strenuous activity; high elevation; sharing ski area facilities and EVENT venues with people directly involved and/or not directly involved in the EVENT. PARTICIPANT understands and acknowledges he/she has been informed and understands all rules and regulations of participating in the EVENT. PARTICIPANT is responsible for reading, understanding and complying with all signage, including instructions on the use of the lifts. PARTICIPANT recognizes that falls and collisions occur and injuries are a common and ordinary occurrence of the EVENT. If participating in a competition PARTICIPANT understands that he/she may take the opportunity to inspect the venue prior to participation.

I understand that inverted aerial maneuvers are prohibited. I understand that the use of Helmets is required in order for me to participate in the Event.

I agree that all disputes arising under this contract or my use of any facilities at this ski resort, shall be litigated in the State or Federal courts and governed by the laws of the state of Utah and in no other jurisdiction.

In the case of a minor PARTICIPANT, the undersigned parent or legal guardian acknowledges that he/she is also signing this release on behalf of the minor PARTICIPANT and that the minor PARTICIPANT shall be bound by all the terms of this release. Additionally, **by signing this release as the parent or legal guardian of a minor PARTICIPANT, the parent or legal guardian understands that he/she is waiving certain rights on behalf of the minor that the minor otherwise may have.** The undersigned parent or legal guardian agrees that but for the foregoing, the minor would not be permitted to participate in the EVENT. The undersigned parent or legal guardian also agrees that if the PARTICIPANT is injured, the parent or legal guardian authorizes medical care for the PARTICIPANT and/or transport of the PARTICIPANT to a medical facility at the parent/legal guardian’s expense. No provision in this Release shall create a duty to provide medical care or transportation to any PARTICIPANT. The furnishing of medical care is neither an admission nor an assumption of liability by the Released Parties.

By signing this release without a parent or guardian’s signature, the PARTICIPANT represents that he/she is at least 18 years of age, or, if signing as the parent or guardian of the PARTICIPANT, you represent that you are the **legal** parent or guardian of the minor PARTICIPANT.

THE UNDERSIGNED agree and understand that this release is applicable to each and every day PARTICIPANT participates in the EVENT.
